- c) DAR & Neighbors Plan Cemetery Restoration, a few members plan on helping. Sid to contact Judy Kurtz regarding his contact that may be able to supply cleaning materials.

New Business:

- a) Chad received clothing order and sold most of it. Chad to place a new order. Also, Chad has purchased totes for clothing storage as needed. Clothing order may not come in until October due to backorder on materials.
- b) Landowner from Browns Pit to Oregon road has signed a landowner permission form. TOW will have to reroute some of the upper section as the owner will be building. TOW to flag out alternate route and go over with each landowner.
- c) Landowner at Jacques & Bombard Road has not met up with Chad yet.
- d) Miles Pond pavilion is not a trailhead. Steve to post on twitter and the town has posted the same on their web site.
- e) Poker Run is tentatively scheduled for September 18th, Steve has reserved the pavilion. It was decided to serve hamburgers, hotdogs, chips, and water only.
- f) Naults has said that they will donate prizes for the poker run.
- g) Members to propose a two-hour route for poker run, proposals to be reviewed and one selected to be used.
- h) Poker run to start at 9:00am and finish up at 1:00pm.
- i) Discussion was had regarding a new trail around the state land on Carr Brook.
- j) Steve to submit for trailwork from Carr Brook to Horn of the Moon to VASA while they are in the area.
