- a) Trail relocation (bad section up Miles Mt.) was presented by Chad. VAST is applying for a grant to relocate from the lower section by apple orchard to Carr Brook. Larry has given the clubs 12 months to take care of or both clubs will not be able to use his land any longer.
- b) Oregon trail that previously needed to be relocated is on hold for now as property is up for sale.
- c) York rake has been purchased.
- d) Memorial Day Parade starts at 10:00 am. Assemble at 9:30 am at foundry.
- e) Green Up is today.
- f) Chad has not been able to locate an axle for the Ranger. Pine asked Chad to send him specs and he will check to see if he has one.
- g) Trail work request from VASA (Carr Brook to Horn of the Moon) was discussed. VAST did some work on the upper trail last fall. Chad to check with Larry Brown to see if we should also do the trail Larry had made for us previously or the third trail or nothing at all.
- h) Chad presented bill for ranger repair work for \$368.65.

- j) Motion was made to donate \$100.00 to the Concord 8th grade for doing the cooking at the Memorial Day parade.
